In consideration for Zodi Outback Gear, LLC ("Zodi") extending credit to me (US), I (WE) hereby agree to the following: that a representative of Zodi may contact any person above for verification of fact or payment of funds; that I (WE) will notify you immediately of any changes in the facts set forth above; that all invoices will be paid within the terms indicated.

I (WE) agree that in the event any portion of this account shall become delinquent, any and all invoices on my (OUR) account including future dated invoices shall, at the sole discretion of Zodi, become due and payable immediately.

The undersigned promises to pay for all purchases in accordance with Zodi's terms of sale. If at any time the undersigned is unable to pay for said purchase when due, the undersigned agrees to pay and hereby authorizes Zodi to bill my (OUR) account interested computed at 1-1/2% per month (18% annum) on any past due amount (s). If it becomes necessary for Zodi to incur collection costs for any amount due under this agreement the undersigned promises to pay all additional collection costs including reasonable attorney fees. All disputes arising under or pursuant to this agreement will be construed according to the laws of Utah and will be submitted to the courts or arbitration in Summit County, Utah.
